## Make your wishes known

There are many ways to leave a legacy gift to *On This Rock 2*.

You can designate outright gifts of cash, securities and real property through a variety of tax-advantaged structures:

- A gift under your will or through a Living Trust or Revocable Trust
- Lifetime income for you with a Charitable Remainder Annuity Trust
- A Charitable Remainder Unitrust
- An Irrevocable Life Insurance Trust
- Naming LCPC as a beneficiary of one of your IRA or pension fund accounts
- A gift from your pension fund or profit sharing assets
- A gift of your personal residence through a Retained Life Estate
- A Charitable Lead Trust
- A Donor Advised Fund
